WARRANT

STATE OF KANSAS, SEDGWICK COUNTY, ss:

THE STATE OF KANSAS to any Law Enforcement Officer:

WHEREAS, Complaint/Information in writing, under oath, and/or an affidavit or other evidence has been filed with the undersigned magistrate at Wichita, Sedgwick County, Kansas, and the undersigned magistrate finds that there is probable cause to believe that in the County of Sedgwick and State of Kansas, on or between the 6th day of November, 2010 A.D. and the 7th day of November, 2010 A.D., one TERRY E. BLUM did then and there unlawfully and intentionally engage in lewd fondling or touching of a child who was under fourteen (14) years of age, to-wit: KLB, age: 9, year of birth: 2001, or of the defendant by such child, done with the intent to arouse or satisfy the sexual desires of the child, the defendant or both;

Contrary to Kansas Statutes Annotated 21-3504(a)(3)(A), Aggravated Indecent Liberties, Severity Level 3, Person Felony

all of the said acts then and there committed being contrary to the statutes in such cases made and provided and against the peace and dignity of the State of Kansas.

You are, therefore, commanded forthwith to arrest the said: **TERRY E. BLUM** and bring **TERRY E. BLUM** before a magistrate as provided by law.

The amount of the appearance bond to be required is \$ 100,000⁰⁰.

Bond conditions shall include:

- No contact with the victim or State's witnesses.
- Pre-trial Services with electronic monitoring device.
- No contact with anyone under the age of sixteen (16) without authorized responsible adult being present.
